Proposed activity or matter for discussion:

This paper continues on from the discussion held at the October 2007 Board meeting. Taking the 'tone' of that meeting, I re-submit this paper as under.

Subscription classes and levels were originally conceived in the run-up to Gay Games 2002 when the structure of Team Sydney was significantly different to today. I propose that the classes of membership and subscriptions should be revisited and modified. This can be done by the Board, constitution clause 9.3.

### Definitions:

- (1) *These classes of personal membership are entitled to vote at General Meetings. Member Organisations are eligible, through their delegate, to vote at Sports Council and General Meetings*
- (2) *Teams, clubs and organisations entitled to full participation in Team Sydney activities and to appoint a delegate to the Team Sydney Sports Council.*
- (3) *Groups, clubs and organisations not eligible to appoint a delegate to the Team Sydney Sports Council, have no voting rights and that must pay a fee \* to participate in Team Sydney activities.*

### Present classes of membership and subscriptions:

(1) Honorary Life Member:	No subscription
(1) Personal Member:	A\$20.00 per year
(1) Personal Member – Concession Card:	A\$15.00 per year
(1) Personal Member – member of Member Organisation:	A\$10.00
(2) Member Organisation:	A\$55.00
(3) Affiliate Organisation:	Nil.

### Proposed classes of membership and subscriptions:

(1) Honorary Life Member:	No subscription
(1) Personal Member: (No concessions – the rate is cheap already)	A\$15.00 per year
(2) Member Organisation: (Reduced from \$55)	A\$44.00 per year
(3) Affiliate Organisation: (New rate – not previously determined)	A\$22.00 per year *

*NB: With the exception of Member Organisations, Team Sydney currently absorbs GST. In this proposal, subscriptions will include GST and any other expenses (eg. PayPal) and be payable by the member.*

\* At the discretion of the Board and on a case-by-case basis, Affiliates may be charged a Participation Fee for activities such as Sports Day Out and similar.
